  - In case of cooperation or contract conclusion, the data will be used to fulfill the contract; After fulfillment of the contract, the statutory retention periods apply
- Purposes for which the personal data are to be processed Answering your enquiries; if necessary to conclude the contract / fulfillment of the contract, collection and storage of your data as a potential partner company for establishing contact within the phase of contract initiation
- Legal basis for processing
  Art. 6 para. 1 lit. b and lit. f GDPR in conjunction with recital 38
- Legitimate interests within the meaning of Art. 6 para. 1 lit. f GDPR, which are followed by the person responsible



## Data protection information according to Art. 13 GDPR regarding contact and application for partner companies

The contact request originates from the enquirer himself, who actively enters his data into the contact form / to the functional email address in order to contact him. There is no unnoticed data transmission. Specifically, the requestor can foresee which data is requested by the company and for what purpose (contact, processing of the request, if necessary conclusion of the contract) these are processed.
